Dear President Wallace:

I am writing to inform you that on April 30, 2015, the Committee on Accreditation, on behalf of the Commission on Teacher Credentialing, assigned the status of *Accreditation with Stipulations* to Azusa Pacific University and all of its credential programs.

Following are the stipulations to be met:

- By July 1, 2015, Azusa Pacific University is to notify the Commission on Teacher Credentialing if it will close the California Teachers of English Learners (CTEL) program or not. If the decision is to not close the CTEL program, Azusa Pacific University is required to host a focused site visit in fall 2015 for a full review of the CTEL program.
- Azusa Pacific University is to provide the Commission on Teacher Credentialing with a resolution of the existing CTEL program and a plan for students to complete that program.

On the basis of this decision, the institution is authorized to recommend candidates for the following Credentials:
