I am writing to inform you that on May 10, 2018 the Committee on Accreditation, on behalf of the Commission on Teacher Credentialing, assigned the status of **Accreditation with Stipulations** to Notre Dame de Namur University and its credential program. On the basis of this decision, the institution is authorized to offer the following programs:

Within one year, the institution must submit written documentation to the Commission addressing the following stipulations:

1. That the institution provide evidence that site-based supervisors are required to be trained and oriented to their supervisory role in a systematic manner.
2. That the Preliminary MS/SS teaching credential programs provide evidence that candidates are able to demonstrate their knowledge of digital literacies and the use of learning technologies as specified in the Teaching Performance Expectations (TPEs) 3, 4, and 5.
3. That the Education Specialist Moderate/Severe credential program provide evidence that candidates acquire the knowledge and skills necessary to assess students in a comprehensive manner within the breadth of the credential authorization.
4. That the Education Specialist: Moderate/Severe credential program provide evidence that candidates demonstrate understanding of mandated considerations for augmentative and alternative communication technology for students with


moderate/severe disabilities, including students with physical/orthopedic disabilities, other health impairments, deaf/blind, and multiple disabilities.

In addition:

- The institution's response to the preconditions is accepted.
- Notre Dame de Namur University is permitted to propose new credential programs for approval by the Committee on Accreditation.
- Notre Dame de Namur University continues in its assigned cohort on the schedule of accreditation activities as determined by the Commission on Teacher Credentialing.
