Dear Dean Yerrick:

I am writing to inform you that on May 5, 2022, the Committee on Accreditation, on behalf of the Commission on Teacher Credentialing, assigned the status of *Accreditation with Stipulations* to California State University, Fresno and its credential programs. On the basis of this decision, the institution is authorized to offer the following programs:

Preliminary Multiple, with Intern Preliminary Single Subject, with intern Preliminary Education Specialist: Mild/Moderate, with intern Preliminary Education Specialist: Moderate/Severe, with intern Preliminary Education Specialist: Deaf and Hard-of-Hearing, with intern Preliminary Administrative Services, with intern Pupil Personnel Services (PPS): School Psychology, with intern Pupil Personnel Services (PPS): School Counseling Pupil Personnel Services (PPS): School Social Work Pupil Personnel Services (PPS): Child Welfare and Attendance Specialist Teaching: Agriculture Specialist Instruction Specialist Teaching: Bilingual Authorization: Hmong and Spanish Specialist Teaching: Reading and Literacy Added Authorization (RLAA) Specialist Teaching: Reading and Literacy Leadership Specialist (RLLS) Speech-Language Pathology School Nurse

The following stipulations were placed on the institution:

That within one year, the institution provide evidence demonstrating that it has addressed the issues identified by the site visit team as it relates to the following standards that were determined to be less than fully met:

- 1) Common Standard 1 relating to resource issues that impact advising and workload.
- 2) Common Standard 4 demonstrating that it has fully implemented its framework for a unit-wide continuous improvement plan.
- 3) Preliminary Education Specialist: Deaf and Hard-of-Hearing credential specialty area program standards 1, 2, 5, 6, 7, 8, 10 and 11.
- 4) Reading and Literacy Added Authorization and Reading and Leadership Specialist credential program standards 1, 6, 9, and 10.

In addition:

- The institution's response to the preconditions is accepted.
- California State University, Fresno is permitted to propose new credential programs for approval by the Committee on Accreditation.
- California State University, Fresno continues in its assigned cohort on the schedule of accreditation activities as determined by the Commission on Teacher Credentialing.
